#### GoConnect and FlexConnect Terms and Conditions

1. All prices are exclusive of Value Added Tax (VAT) and are based on a 12-month contract period. Early termination fees will apply in the event of contract cancellation before the end of the term.
2. Additional Once-Off Setup Costs will be determined per application.
3. Should a capacity upgrade be required, the existing contract will be terminated, and a new 12-month contract will be initiated. Early termination fees may apply. Please note that capacity upgrades do not permit changes to the start and end points of the route.
4. The start and end points of a route are fixed for the duration of the contract and cannot be changed. Should additional connections beyond the 50 km magnet function be required, a separate route must be acquired.
5. Interconnection is limited to GridOnline Points of Presence (POPs) only.
6. A reconnection fee of N\$500.00 will apply if services are suspended due to client-related causes.
7. Service availability, as well as technical and financial viability, will be assessed at the sole discretion of NamPower. Additional charges may apply depending on the outcome of this assessment.
8. Magnet functions: *FlexConnect* breakouts are permitted within a fibre distance of 50 km (not geographical) from the nearest available connection to the main route.
9. *FlexConnect* services are not available with *GoConnect* services exceeding 100 Gbps, as larger transport capacities are provided on a pure Layer 2 optical architecture.
10. All prices are based on equal prioritisation of VLANs. Custom prioritisation will incur additional charges.
